**26/25. Planning:**

a. **To consider the following planning applications (PA):**

- i. **PA 26/00656/HOU.** Erection of single storey extension to dwellinghouse and replacement of doors on front elevation of outbuilding at The Ford, Hornblotton Green Road, Lovington, BA7 7PS.

The Agent and Applicants were present to answer any questions. Councillors agreed that the proposed extension would meet the project brief to provide more natural light into the dark interior of the dwelling. It would also help to ameliorate the somewhat overbearing impact of the large modern two storey extension on the original cottage, a non-designated heritage asset dating back to the late 17th Century. The clever and balanced design also embraces the garden element and has no impact on neighbouring properties.

**RESOLVED:** Councillors agreed unanimously to recommend **APPROVAL** of this very well designed application.
